- 3. Price shall be inclusive of all cost such as design, quality material, labor and installation. Quote price will be firm and final. No escalation whatsoever shall be payable. The bidder/supplier will be entirely responsible for all taxes and levies payable by them to the respective authorities.
- 4. No advance payment will be made; payment will be made on satisfactory completion of the work as per actual quantity of items and specifications as per work order.
- 5. Supply and Installation shall be completed within 30 days from the date of issue of work order. If the work is not completed within the due date and no extension of date is applied for and granted, JBC reserves the right to impose liquidated damages/cancel the work order including forfeiture of funds submitted by the bidder and no payment for the work already completed shall be allowed.

- 7. Quarterly reports (months of (April June and/or July September) will be required
